Notifications must have been received in writing on the attached form by **29.02.2024** at the latest.

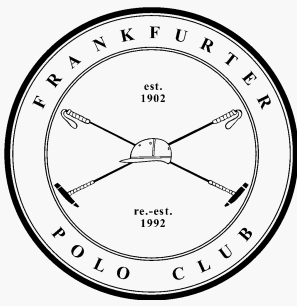

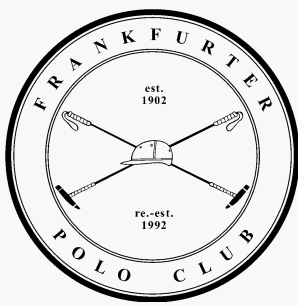

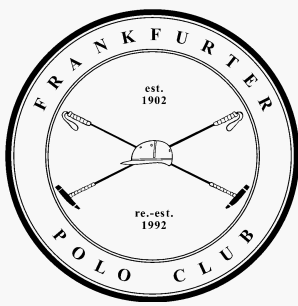

### **Animal welfare:**

Players are asked to keep the valid horse passes of all horses at their disposal. Resolutions in case of missing required vaccinations must be submitted to the tournament management or to the tournament doctor at the latest by the time of entry.

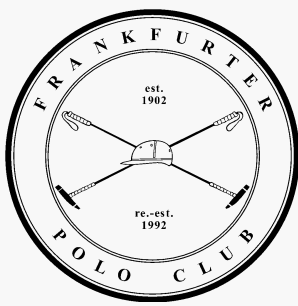
All horses participating in the tournament must have been vaccinated against horse influenza in accordance with HPA rule 2.4 L. The vaccinations must be documented in the horse passport. Vaccinations shall be demonstrated on request by presenting the horse passports in the event grounds.

A horse may not be rented to different teams and may only be used for a maximum of 2 chukkers per day. In the case of infringements, the horse is disqualified.

The tournament veterinarian also has the right to carry out constitutional checks on the participating horses immediately from the date of arrival until the end of the tournament, even unannounced. It also has the right to carry out unnotified resolution checks. These are carried out without suspicion and indication.

Horses that do not pass the constitutional examination remain excluded from the game until a new constitutional examination and participation approval by the tournament veterinarian.

**Violations of animal welfare must be reported to the tournament management. Horses without adequate vaccination protection shall not enter the event grounds.**



## **Medical care**

A rescue service will be present at the field.

## **Tournament cancelation**

Bad weather and / or unplayability of the tournament place lead to the replacement deletion of games and, if necessary, the whole tournament. If the ongoing tournament is cancelled, the current score is decisive for the placement. A refund from the nominal money is excluded.

## **Declaration of consent for photos and film recordings:**

This form must be signed by each tournament participant. In the case of minors, the signature of the legal representatives is required.

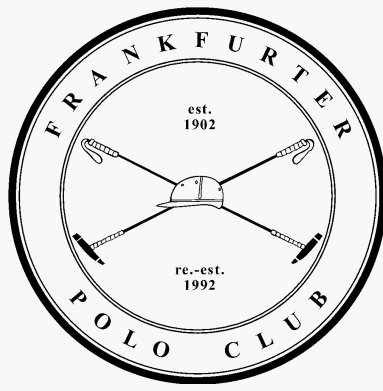
## **Changes in team compositions:**

Changes to the team / exchange of players during the tournament require the consent of all team captains and the tournament management.

## **Team statement:**

Submission of the notification the Team Captain expressly declares to himself and the other players of his team the agreement with the terms and conditions of the tender and the DPV tournament statutes as well as the anti-doping guidelines, animal welfare regulations of the DPV and the general conditions.

This also applies to single player registrations.



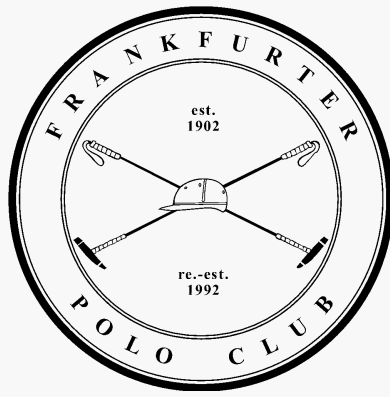
## **Umpire:**

The organizer will appoint an arbitrator for the duration of the tournament. In addition, a second official will support the referee at the edge of the pitch.

The referee horse is to be provided by the teams or rented locally. Its costs are not taken into account in the tournament fees.







## Team shirts:

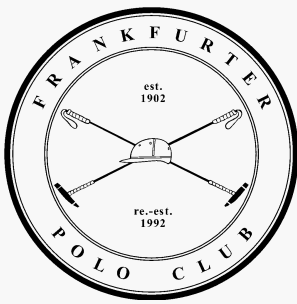
The tournament sponsors make the team T-shirts available.

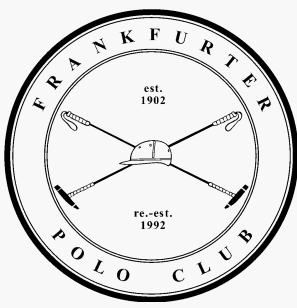

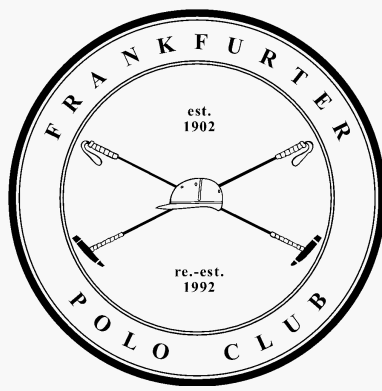
The costs of accommodation are invoiced 7 days before the start of the tournament and are due immediately.
